

## Privacy Policy

This statement comprises the privacy policy (the “**Policy**”) of the European Law Blog (the “**Blog**”; “**we**”; “**us**”). This Policy does not cover the Blog’s presence on social media platforms, such as Twitter. In the context of those platforms, we are merely another user and the privacy policies, as well as the terms and conditions, of those platforms apply.

### 1. Collection of Information

- We collect Personal Information that you provide to us in the following ways:
  - **Contacting the Blog:** If you contact us at [info@europeanlawblog.eu](mailto:info@europeanlawblog.eu), we collect the information you voluntarily provide to us. We will access and process such Personal Information for the purposes as set out below.
  - **Signing up for Blog updates:** We use the subscriptions feature by [Jetpack](#), a WordPress plugin, to manage our email distribution list. When you provide your email address in the “Email Subscription” section of the Blog and click “Subscribe”, your email address is provided by Jetpack to us.
- We may automatically collect the following information when you visit the Blog:
  - **Cookies:** Like most websites, the Blog may place a “cookie” – a small text file – in the browser of your computer. Cookies can be either “persistent” or “session” based. The Blog uses both types of cookies. Session cookies are short-lived, used only during a browsing session, and expire when you quit your browser. Persistent cookies are stored on your computer, contain an expiration date, and may be used to track your browsing behaviour upon return to the issuing website or component. We use the following cookies on the Blog:

For these purposes, analytic cookies collect information about your device type, operating system type, browser type, domain, other system settings, IP-address, referring URLs, information on actions taken on the Sites and the dates and times of your visits, as well as the country and time zone in which your device is located. - We use [Google Analytics](#) and [Jetpack by WordPress](#) which collect technical information, including the operating system and platform, browser type and version, and helps us analyse traffic on the Blog.

## 2. Use of Information

Your Personal Information may be used in the following ways:

- If you have signed up to receive Blog updates, we will use your Personal Information to send you the requested Blog updates;
- If you contact us by email, we will use the Personal Information to respond to your inquiry. In particular, when you email us about writing a post for the Blog, we may share the enquiry and any draft post you send us with the editors of the Blog as part of the editorial process.
- If we decide to publish a post that you have submitted to us, your name and a short biography that you provide will appear on the Blog.

Your information may also be used for technical purposes, including:

- To ensure that content from the Blog is presented in the most effective manner for you and for your device; and
- statistical purposes.

### **3. Disclosure of Information**

We will never share your Personal Information with any other third party without your consent, except in the following circumstances (each as permitted by applicable law):

- as set out in this Policy;
- when we are required to do so by law, for example, in response to a valid request from a law enforcement agency;
- in the event that we sell or transfer all, or any portion of, the Blog (including in the event of any reorganisation, dissolution, spin-off, or liquidation) we reserve the right to transfer your Personal Information to the relevant acquirer, successor, purchaser or beneficiary, or any appropriate combination of them.

### **4. Storage and Accuracy of Information**

The Personal Information you provide when contacting us at [info@europeanlawblog.eu](mailto:info@europeanlawblog.eu) or when signing up for Blog updates is stored on servers in the Netherlands on servers owned by Antagonist our hosting provider.

The accuracy of your Personal Information is important to us. If you change your email address, you may update your email address in our records by clicking “Manage Subscriptions” at the bottom of each of our Blog updates to which you have subscribed. We will only store your Personal Information in our systems for as long as is necessary.

### **5. Security**

We use reasonable precautions to protect your Personal Information and to store it securely. However, no method of transmission over the internet, or method of electronic storage is 100% secure. We will do our best to protect your Personal Information, but cannot guarantee the security of your information transmitted to us.

### **6. Links to other website**

The Blog may provide links to other websites for your convenience and information. These websites may operate independently from us and may have their own privacy policies. To the extent any linked websites are not owned or controlled by us, we are not responsible for their content, any use of the websites or the privacy practices of those websites.
